**ANC 3C Resolution No.2010-017**  
**Resolution regarding The Cleveland Park Historical Society’s Grant Request**  
**for Landscaping and Erosion Prevention for the**  
**Ashley Terrace/30<sup>th</sup> Street Steps and Alley**

WHEREAS The Cleveland Park Historical Society promotes interest in the history of Cleveland Park and encourages the preservation of our architectural heritage and the character of our neighborhood as a friendly, diverse, urban, residential neighborhood with a strong sense of community; and

WHEREAS the CPHS enlists neighbors and volunteers to raise funds and plant and restore tree boxes, a playground and other public spaces to keep Cleveland Park green and attractive has long been a major activity of the Society; and

WHEREAS the CPHS has raised funds through community donations and a fundraising event held by a local commercial establishment to cover the cost of a landscaping and erosion prevention project for the newly repaired Ashley Terrace and 30<sup>th</sup> Street steps and alley; and

WHEREAS the CPHS has submitted a grant request to the Advisory Neighborhood Commission 3C (ANC3C) for \$2,674 to help defray the cost of the landscaping and erosion prevention project; and

THEREFORE BE IT RESOLVED ANC3C approves the grant request for \$2,674 on condition that the grant recipients will comply with the ANC3C requirements regarding accounting and reporting procedures; and

BE IT FURTHER RESOLVED that the Chair, Commissioner for ANC 3C05 and the ANC 3C Treasurer are authorized to represent the Commission regarding this matter.
