**Regarding a Request from Burka's Fine Wines & Liquors (Burka's) for a Stipulated Alcohol License (ABRA #086394)**

WHEREAS, Burka's, located at 3500 Wisconsin Ave. NW, is moving to 3414 Wisconsin Ave. NW;

Whereas, Burka's is seeking a stipulated license from the Alcoholic Beverage Regulatory Administration (application #086394). Such a stipulated license would allow Burka's to operate during a 45-day public notice period prior to its existing alcohol license being transferred to the new location;

Whereas, Burka's has operated in the neighborhood for many years and enjoys the support of many residents;

THEREFORE, BE IT RESOLVED that the ANC3C:

Supports Burka's request for a stipulated license to allow it to operate for 45 days in its new location at 3414 Wisconsin Ave. NW before its existing license is transferred to the new location;

FURTHER, BE IT RESOLVED that the Chair and Commissioner for ANC3C06 or their designees are authorized to represent the Commission in this matter.
