This letter is to accompany the DDOT form that indicates that ANC 3C has no objection to the enclosed sidewalk café at La Piquette, 3714 Macomb Street, N.W. This letter was approved along with the enclosure application at a regular, noticed meeting of ANC 3C tonight, January 22, 2020, at which a quorum was present.

This is to bring to your attention that all of the permitted sidewalk cafes on the 3700 block of Macomb St. predated the reopening of the treeboxes in public space. They had been paved over for many years, and in an effort to improve the appearance of the street and enhance the businesses, DDOT agreed to reopen the treeboxes and plant trees. One unfortunate result of what was generally a very positive project, was that the distance from the edge of the treebox to the sidewalk cafes was non-compliant by about two feet. The ANC was aware of this when we urged DDOT to improve the street.

Two of the four sidewalk cafes have enclosures despite this abnormality. The ANC has not received any complaints about lack of pedestrian space. We urge you to approve this application given this unusual circumstance relative to the distance from the treebox to the sidewalk café.
