ANC3C RESOLUTION No. 2022 - 002

Stipulated Alcohol License for Maddy’s Tap Room, LLC (Maddy’s Pizza), located at 2619 Connecticut Avenue (ABRA # 086-770)

WHEREAS, Maddy’s Tap Room, LLC requested to ‘transfer their DC Alcoholic Beverage Regulation Administration (ABRA) Class C business license’ to a new location within the Woodley Park Commercial District under the D.C. Alcoholic Beverage Control Act in order to serve beer, wine, and spirits within their restaurant;

WHEREAS, Maddy’s Tap Room, LLC requests to ‘transfer their license’ from 1100 13th Street, N.W., to 2619 Connecticut Avenue, N.W., with ‘substantial changes.’ The licensee is requesting to decrease the total occupancy load inside of the premises from 115 to 98, to decrease the seating of the outdoor sidewalk café from 50 to 28, to add an entertainment endorsement to the inside of the premises, and to change the hours of the outdoor sidewalk café;

WHEREAS; the **current hours** of operation and hours of alcoholic beverage sales, service, and consumption *inside the premises* and for the *outdoor sidewalk café* respectively are as follows:

- Sunday through Thursday from 8:00am to 2:00am, and Friday and Saturday 8:00am to 3:00am
- Sunday through Saturday from 11:00 am to 12:00 am

WHEREAS; the **proposed hours** for *live entertainment inside the premises* and the proposed hours of operation and hours of alcoholic beverage sales, service, and consumption for *inside the premises* and the *outdoor sidewalk café* respectively are as follows:


- Sunday through Saturday from 8:00 am to 11:00 pm
- Sunday through Thursday from 8:00am to 2:00am, and Friday and Saturday 8:00am to 3:00am
- Sunday through Saturday from 10:00 am to 1:00 am

WHEREAS, Maddy's Tap Room, LLC (Maddy's Pizza), is seeking a stipulated license from ABRA - whereas such would allow the applicant to operate during a 66-day public notice prior to its new Class C business license being issued;
