ANC3C Resolution 2022-027
Congratulating Commissioner Lee Brian Reba for Service to the Community

Whereas, Advisory Neighborhood Commission 3C (ANC3C) is a non-partisan, neighborhood body made up of locally elected representatives called Advisory Neighborhood Commissioners.

Whereas, Advisory Neighborhood Commissioners serve two-year terms without pay, are elected at DC Elections in November in even-numbered years, and are a unique feature of the District's Home Rule Charter.

Whereas, Lee Brian Reba was first elected as an Advisory Neighborhood Commissioner in 2008.

Whereas, Lee Brian Reba has served the community as an Advisory Neighborhood Commissioner for 14 years, and has served as Secretary for a part of his tenure as well.

Whereas, Lee Brian Reba decided not to seek re-election during the election year 2022;

Whereas, Lee Brian Reba is the second-longest serving member in the Commission's history, during which he has attended well over 100 ANC meetings. This does not include the countless committee meetings and meetings outside of official venues, discussing with applicants their neighborhood projects or issues.

Whereas, Lee Brian Reba has served as the ANC 3C representative to the Smithsonian National Zoological Park, an important stakeholder in our neighborhood.

Whereas, Lee Brian Reba has worked for his constituents and community to serve in this unpaid and volunteer role, taking time away from family, friends and work.

Therefore, Be It Resolved that ANC 3C congratulates Lee Brian Reba for his service as an Advisory Neighborhood Commissioner to the community.

Be It Further Resolved that ANC 3C expresses its appreciation and gratitude for those contributions and wishes him well in all the years to come.

Be It Further Resolved that the ANC authorizes the Chair and the Commissioner for 3C05 to represent the Commission on this matter.
