**ANC3C Resolution 2022-028**  
**Congratulating Commissioner Nancy MacWood for Service to the Community**

Whereas, Advisory Neighborhood Commission 3C (ANC3C) is a non-partisan, neighborhood body made up of locally elected representatives called Advisory Neighborhood Commissioners.

Whereas, Advisory Neighborhood Commissioners serve two-year terms without pay, are elected at DC Elections in November in even-numbered years, and are a unique feature of the District's Home Rule Charter.

Whereas, Nancy MacWood was first elected as an Advisory Neighborhood Commissioner in 2000.

Whereas, Nancy MacWood has served the community as an Advisory Neighborhood Commissioner for 22 years, the longest serving member in the Commission's history, and has served as Chair for ANC3C for most of her tenure, and chair or co-chair of the Planning and Zoning committee for all 22 years.

Whereas, Nancy MacWood's tenure is the longest tenure of any commissioner in the history of ANC3C, participating in over 200 ANC meetings and over 100 committee meetings. This does not include the countless meetings outside of official venues, discussing with applicants their neighborhood projects or issues.

Whereas, Nancy MacWood has served as the ANC 3C representative to the boards of both the Tregaron and Rosedale Conservancies.

Whereas, Nancy MacWood decided not to seek re-election during the election year 2022;

Whereas, Nancy MacWood has worked for her constituents and community to serve in this unpaid and volunteer role, taking time away from family, friends and work.

Therefore, Be It Resolved that ANC 3C congratulates Nancy MacWood for her service as an Advisory Neighborhood Commissioner.

Be It Further Resolved that ANC 3C expresses its appreciation and gratitude for those contributions and wishes her well in all the years to come.

Be It Further Resolved that the ANC authorizes the Chair and the Commissioner for 3C05 to represent the Commission on this matter.
