ANC3C Resolution 2023-002
Regarding Residential Historic Preservation Review Committee

WHEREAS, Advisory Neighborhood Commission 3C (ANC 3C or Commission) is committed to promoting stewardship of the District of Columbia's historic and cultural resources through supporting the Historic Preservation Review process of the Office of Planning;

WHEREAS, ANC 3C has the opportunity to provide input on matters of Historic Preservation including, but not limited to, designating historic landmarks and historic districts, recommending nominations to the National Register of Historic Places, establishing procedural rules, design standards, and design guidelines, review proposed construction for compatibility with historic properties, and facilitating public comment in the preservation planning process;

WHEREAS, ANC 3C includes the Cleveland Park Historic District and the Woodley Park Historic District;

WHEREAS ANC 3C tasks the PZHED committee with HPRB applications for commercial, multifamily and institutional projects; and

WHEREAS, residential [Single Family Home (SFH)] HPRB applications have different design guidelines and neighborhood context than commercial, multifamily and institutional projects, as envisioned by the Cleveland Park Historical Society's preservation design guidelines for the residential portion of Cleveland Park that lies between Connecticut and Wisconsin Avenues.

THEREFORE, BE IT RESOLVED that ANC 3C establishes a Residential Historic Preservation Review Committee as a standing committee;

BE IT FURTHER RESOLVED that the Residential Historic Preservation Review Committee is tasked with the following:

- Reviewing HPRB applications and issues directly related to historic preservation of single-family residences. This includes the residential portion of Cleveland Park that lies between Connecticut and Wisconsin Avenues and the single-family residences in Woodley Park.
- Drafts resolutions for reviewed HPRB applications of single-family residential properties. This includes the residential portion of Cleveland Park that lies between Connecticut and Wisconsin Avenues and the single-family residences in Woodley Park.
- Makes recommendations to the Commission on historic preservation matters regarding HPRB applications of single-family residential properties.
- Together with the Single Member District (SMD) commissioner in whose district the subject HPRB application arises, draft proposed resolutions for review of HPRB applications in single-family homes.

- Together with the SMD commissioner in whose SMD the subject HPRB application arises, make recommendations to the Commission on historic preservation matters regarding HPRB applications in single-family homes.

BE IT FURTHER RESOLVED that Sauleh Siddiqui, Commissioner for SMD 3C05, Commissioner Gawain Kripke, Commissioner for 3C07, and Commissioner Rick Nash, Commissioner for 3C08, shall be the Co-Chairs of the Residential Historic Preservation Review Committee of ANC 3C for the Commission Year 2023;

BE IT FURTHER RESOLVED that the Committee Chair shall appoint, with the approval of the Commission, additional members of the Committee;

Be It Resolved that the ANC authorizes the Chair and the Commissioners for 3C05, 3C07, and 3C08 to represent the Commission on this matter.
