## ANC3C Resolution 2023-CONSENT Regarding Cleveland Park Participation in 2023 Art All Night (Saturday, September 30, 2023)

WHEREAS DC Art All Night 2023 will occur from 7:00 PM to 3:00 AM the following morning on two nights—September 29 and 30. The festival will take place in all 8 wards with different activations on each night, bringing visual and performing arts, including painting, photography, sculpture, crafts, fashion, music, literary arts, dance, theater, film, and poetry, to indoor and outdoor public and private spaces, including local businesses and restaurants;

WHEREAS Art All Night 2023 is a chance for the city to celebrate the performing and visual arts. D.C. will be the center stage showcasing our city's talent diversity. The event highlights the intersection of art and business throughout our commercial corridors, placing artists on the center stage;

WHEREAS Art All Night is a collaboration between the D.C. Department of Small and Local Business Development (DSLBD), D.C. Commission on the Arts and Humanities Department (DCCAH), D.C. Public Library (DCPLS), and the D.C. Main Streets programs, and the Business Improvement Districts. Each participating neighborhood will be a catalyst for corridor revitalization by highlighting music, visual, literary and performing arts, activating public spaces, bringing new foot traffic to small and local businesses within the corridor, and bringing an increase in business sales compared to a typical weekend night;

WHEREAS Saturday, September 30, 2023 will be Cleveland Park's first participation in Art All Night. This year's Event is likely to bring 1,000-2,000 visitors to Cleveland Park and participation is intended to reinforce Cleveland Park as a lively destination for neighbors and visitors alike;

- Live Chalk Art Outside 3416 Connecticut Avenue NW 5-7pm
- Roaming Puppets 5-7pm
- Puppet Making Workshop at Laredo 5-7pm (different from Roaming Puppets)
- Artechhouse Location and time TBD

WHEREAS Cleveland Park restaurants wishing to participate by hosting music will need to acquire a temporary/permanent music endorsement from ABCA;

THEREFORE, BE IT RESOLVED Advisory Neighborhood Commission 3C supports Cleveland Park Main Street's participation in the 2023 Event;

BE IT FURTHER RESOLVED Advisory Neighborhood Commission 3C calls on ABRC, DDOT, DCRA and any other District Agencies that may have jurisdiction over permitting matters to approve all applications associated with the Event;

BE IT RESOLVED the Commission authorizes the Chair to represent the Commission on this matter.
