

Permitting

Permit Status

WIS was required to submit a Modification of Consequence to minor design comments from DOB to secure release of the bldg. permit.

- Over the past 30 days, WIS formally received the ANC's approval on te Modification of Consequence submission for the enlarged subgrade building footprint and skylight elevation at the South façade. The Tregaron Conservancy also posed no objections.
- The final step required to obtain DOB's approval of the Modification of Consequence was the BZA's review and approval during the upcoming monthly Zoning meeting on 12/6/23.
- The Modification of Consequence was voted on by the BZA during the 12/6 meeting and approved by a vote of 4-0. WIS' zoning attorney expects the bldg. permit issuance by DOB to occur either by the end of December, or early January.


Construction Schedule Updates

Due to the delay in receiving the Foundation to Grade (FTG) permit, minor weather events, and encountering pockets of contaminated soils, the project excavation period has extended into Mid Dec-2023.

To regain lost time and maintain the contracted project completion, MCN accelerated the concrete, façade, and interior scopes of work.
