**RE: ANC3C Support of Weekly Markets in Woodley Park by the Woodley Park Business Foundation**

To Whom It May Concern,

At a regularly scheduled and properly noticed public meeting on June 16, 2024 with a quorum present, a quorum being five commissioners, Advisory Neighborhood Commission (ANC) 3C voted 7-0-0 to support the following:

- ANC3C writes in Support of the Woodley Park Business Foundation's request for weekly markets in Woodley Park, commencing on Saturday, July 19, 2025 and weekly thereafter;
- ANC3C is in support of any requests made to the Government of the District of Columbia in relation to these weekly markets;
- ANC3C is in support of the use of the 2300 through the 2400 block of Calvert Street, NW and understands there will be tents not exceeding 10x10 and therefore not impairing pedestrian access of the Calvert Street Sidewalk;
- ANC3C is furthermore in support of the use of the 2600 block Connecticut Avenue, NW and understands there will be tents not exceeding 10x10 and therefore not impairing pedestrian access of the Connecticut Avenue Sidewalk;
- ANC3C further asks the Government of the District of Columbia to cancel any permits or pending permits for this space issued to "Historic Dupont Circle Main Streets dba Woodley Park Main Streets".

This event is a community building opportunity that highlights the qualities of Woodley Park and we would like the Government of the District of Columbia to support it as needed.

The Commission authorizes the Chair and the Commissioners for 3C02 and 3C01 and/or their approved designee(s) to represent the Commission on this matter.
